

## Mechirat Hametz (The Selling of Hametz)

On Pesach, we are forbidden to eat hametz and to have it in our possession. For that reason, the ceremony of mechirat hametz (the selling of hametz) should be performed.

The hametz which is in your house over Pesach must be sealed and locked away, preferably in a place other than the kitchen. That hametz should be sold to a non-Jew since it is prohibited for a Jew to own hametz over Pesach. The hametz is then purchased back again after the holiday.

The proper way to sell hametz is to have a Rabbi perform the sale for you. Rabbi Caine will be available to conduct the sale of hametz at the following times: Monday, April 15, from 11:00 a.m. - 1:00 p.m., Wednesday, April 17, from 11:00 a.m. - 1:00 p.m., and Wednesday, April 17, immediately following minyan.

Please understand that your home need not be completely

kosher for Pesach at the time of the sale. The sale does not take effect until the time of the prohibition of eating hametz.

At the time that you sell your hametz, it is customary to make a donation to the Ma'ot Hittim fund, money distributed to those in need at Pesach. If you would like to contribute to this fund, please send a check payable to the Beth Israel, marked for Ma'ot Hittim.

The tradition of selling hametz can be done in person, or you may fill in the form below and send it so it reaches Rabbi Caine by Thursday, April 18. Your name will be added to the document of sale. You may FAX your form to 665-2733, but **please do not** use e-mail, since a signature is needed.

If you do send the form in, please consider sending a contribution to the Discretionary Fund for Ma'ot Hittim. You may also

We strongly urge you to use the Pesach cleaning as an opportunity to donate unopened hametz to the needy. Please make this a part of your Pesach preparation.

The ceremony of searching for hametz should be done on Thursday, April 18th. The hametz should be burned on Friday morning, April 19th.

Copies of a guide to performing the ceremony of searching for and burning the hametz will be available in the synagogue office before the holiday.
